STATE OF SOUTH DAKOTA JOINT POWERS FINANCIAL AND MAINTENANCE AGREEMENT BETWEEN DEPARTMENT OF TRANSPORTATION AND YANKTON COUNTY, SOUTH DAKOTA

This Agreement is made by and between the State of South Dakota, acting by and through its Department of Transportation, referred to in this Agreement as the "STATE," and Yankton County, South Dakota, referred to in this Agreement as the "COUNTY." The STATE and the COUNTY concur in the construction of a Federal Aid Construction Project in the Roadway Safety Improvement Category, listed in the Department of Transportation Statewide Transportation Improvement Program for Fiscal Year (FY) 2025, in Yankton County, South Dakota, as follows:

1. JOINT POWERS

This Agreement does not establish a separate legal entity, as contemplated by SDCL 1-24-5. The cooperative undertaking described in this Agreement will be financed and conducted under the provisions of this Agreement by the COUNTY and the STATE. Each party has responsibilities under the terms of this Agreement and no joint board or administrator will be used. No real property will be purchased for use for this Agreement.

2. STATE PROJECT

The STATE and the COUNTY concur in the proposal for the Rumble Strip/Pavement Marking/Signing project identified as Roadway Safety Improvement Project Number PH 0010(166) PCN 06UA, located on various COUNTY roads in Yankton County, referred to in this Agreement as the "PROJECT."

3. CONTRACT PROCUREMENT

- A. The STATE will design, advertise, let to contract, and be the contracting party for the PROJECT.
- B. The STATE will obtain the required environmental clearances for the PROJECT.
- C. The STATE will provide construction engineering including construction supervision and inspection.
- D. The COUNTY will have the sole obligation and responsibility for maintenance of the PROJECT. The COUNTY will maintain the pavement markings, signing, and rumble strips in like materials, and in the same manner, dimensions, and locations as originally established by the STATE, so long as the pavement markings, signing, and rumble strips conform with standards found in the Manual on Uniform Traffic Control Devices (MUTCD) in effect at the time of this Agreement until such time as the pavement markings, signing, or rumble strips reach their respective end of life, whichever is the later in time. For purposes of this Agreement, end of life is four (4) years for the pavement markings, end of life is eight (8) years for the signing, and end of life for the rumble strips is the end of the second chip seal or until the surface is replaced, whichever occurs first.

4. FINANCIAL RESPONSIBILITY

The PROJECT is one hundred percent (100%) eligible for Highway Safety Improvement Program (HSIP) federal funding. The STATE will pay for all costs incurred under this Agreement, excluding costs associated with maintenance of the PROJECT.

5. INDEMNIFICATION

The COUNTY will indemnify the STATE, its officers, agents, and employees against any and all actions, suits, damages, liability, or other proceedings that may arise as the result of performing services under this Agreement. This section does not require the COUNTY to be responsible for or defend against claims or damages arising solely from errors or omissions of the STATE, its officers, agents, or employees.

6. RECORDS RETENTION AND AUDIT

- A. All PROJECT charges will be subject to audit in accordance with the STATE'S current procedures and United States Office of Management and Budget (OMB) Circular regulations, found at 2 CFR Part 200. The CFDA Number for these funds is 20.205. Allowable costs will be determined in accordance with 2 CFR Part 200.
- B. Upon reasonable notice, the COUNTY will allow the STATE or U.S. Department of Transportation representatives to examine all records of the COUNTY related to this Agreement during the COUNTY'S normal business hours. The COUNTY will keep all records for a period of three (3) years after the date of final payment is made by the STATE under this Agreement and all other pending matters are closed.
- C. If the COUNTY expends Seven Hundred Fifty Thousand Dollars (\$750,000.00) or more in federal funds during any COUNTY fiscal year covered, in whole or in part, under this Agreement, the COUNTY will be subject to the single agency audit requirements of the U.S. Office of Management and Budget (OMB) Circular regulations, found at 2 CFR Part 200. If the COUNTY expends less than Seven Hundred Fifty Thousand Dollars (\$750,000.00) in federal funds during any COUNTY fiscal year, the STATE may perform a more limited program or performance audit related to the completion of Agreement objectives, the allowability of services or costs and adherence to Agreement provisions.

7. AMENDMENT

This Agreement may not be amended, except in writing, which writing will be expressly identified as a part of this Agreement and be signed by an authorized representative of each of the parties.

8. TERMINATION

The STATE may terminate this Agreement on thirty (30) days' written notice. If the COUNTY breaches any of the terms or conditions of this Agreement, the STATE may terminate this Agreement at any time with or without notice.

9. EMPLOYEE STATUS

Any officer, employee, or agent engaged in joint action under this Agreement will remain an employee with his or her agency during participation in joint action under this Agreement. Each agency will retain exclusive responsibility for its officers, agents, and employees while these officers, agents, and employees are engaged in joint action under this Agreement, including but not limited to responsibility for regular and overtime wages and salaries, unemployment benefits, workers' compensation coverage, health insurance, or other benefits, and liability coverage and indemnity, except as otherwise specifically provided in this Agreement.

10. CERTIFICATION OF NO PROHIBITED STATE LEGISLATOR INTEREST

The COUNTY (i) understands neither a state legislator nor a business in which a state legislator has an ownership interest may be directly or indirectly interested in any contract with the State that was authorized by any law passed during the term for which that legislator was elected, or within one year thereafter, and (ii) has read South Dakota Constitution Article 3, Section 12 and has had the opportunity to seek independent legal advice on the applicability of that provision to this Agreement. By signing this Agreement, the COUNTY hereby certifies that this Agreement is not made in violation of the South Dakota Constitution Article 3, Section 12.

11. SIGNATURE AUTHORIZATION

The COUNTY has designated its County Commission Chairperson as the COUNTY'S authorized representative and has empowered the Chairperson with the authority to sign this Agreement on behalf of the COUNTY after consideration of the matter during a regularly scheduled meeting. A copy of the COUNTY'S Board of Commissioner's minutes or resolution authorizing the execution of this Agreement by the Chairperson as the COUNTY'S authorized representative is attached to this Agreement as Exhibit A.

By signature of their representatives below, each party certifies that approval of this Agreement by ordinance, resolution, or other appropriate means has been obtained by that party's governing body or officer pursuant to SDCL \S 1-24-3 and \S 1-24-6.

YANKTON COUNTY BOARD OF COUNTY COMMISSIONERS YANKTON COUNTY, SOUTH DAKOTA SUPERVISORS' RESOLUTION ESTABLISHING NECESSITY FOR IMPROVEMENT RESOLUTION#

WHEREAS, the citizens residing along the township roads named Kaiser Road and 434 Avenue approached the Board of County Commissioners requesting improvements be made to this section of township roads; and

WHEREAS, either ninety percent or greater of the parcels with residential or commercial structures within the improvement zone support implementation of a property tax assessment on their properties to fund the costs for improvements to which all parcels with residential or commercial structures will be assessed or less than 90% of the parcels with residential or commercial structures within the improvement zone support implementation of a property tax assessment on their properties to fund the costs for improvements of which only those supporting parcels will be assessed; and

WHEREAS, the Legislature of the State of South Dakota has provided for the improvement of streets within platted land or subdivision for which a special assessment is to be levied by the board of supervisors of the townships of said State pursuant to SDCL Chapter 31-13 as amended; and

WHEREAS, SDCL 31-13-33, as amended, provides that the board of supervisors shall state the streets to be improved, the general nature of the proposed improvement, the material to be used or materials from which a choice may be made, an estimate of the total cost per linear foot, a description of the classes of lots to be assessed, and the method of apportioning the benefits thereto as provided in SDCL 31-13-42 to 31-13-46 inclusive; and

WHEREAS, SDCL 31-13-46, as amended, provides in lieu of front foot basis that the cost shall be assessed against all assessable lots and tracts of land fronting or abutting thereon or lying within one-half block or three hundred feet thereof, whichever is less, according to the benefits determined by the board of supervisors to accrue to each of such lots and tracts from the construction of the improvement; and

WHEREAS, owners of platted parcels beyond three hundred feet of the improvement and who utilize this township road as their primary access have voluntarily subjected their property for this improvement assessment; and

WHEREAS, the Board of County Commissioners acting as the Board of Supervisors under these statutes has determined that each participating parcel listed in this resolution will benefit equally from the improvement as allowed for by SDCL 31-13-46, as amended; and

WHEREAS, SDCL 31-13-51 and 31-13-52 allow for the Board of County Commissioners acting as the Board of Supervisors under these statutes to levy an annual front foot assessment for maintenance and repairs of a street surface; and

WHEREAS, the Board of County Commissioners recognizes the need for housing development and the improvement of roads for this purpose in the residentially or commercially zoned properties of the county; and

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Yankton County Board of Commissioners acting as the Board of Supervisors under these statutes approves the following regulations applicable to the implementation of this improvement project to be referred to as the **''Kaiser Road and 434 Avenue Improvement Zone'':**

1. Streets to be improved:

The Kaiser Road and 434 Avenue Improvement Zone comprises the county secondary road named West 11th Street from its junction with Deer Boulevard (437tl' Avenue) eastward to its intersection with

the City of Yankton. Access approaches along this improvement are not included in the improvement and remain the responsibility of the parcel owner.

2. Material to be used or materials from which a choice may be made:

Surfacing entails the placement of additional gravel where needed, inclusion of base stabilizer, application of two layers of chip seal and the application of pavement markings.

3. Estimate of the total cost per linear foot:

Estimated total project cost is \$133,575 encompassing approximately 6,864 linear road feet, which yields a per linear road foot cost of \$19.46.

4. Description of the classes of lots to be assessed:

There are thirty-seven (37) zoned parcels having residential or commercial structures included in this resolution that are within 300 feet of the improvement. Of these thirty-seven (37) parcels, six (6) do not contain residential or commercial structures and will not be assessed until a residential or commercial structure is constructed upon them.

Therefore upon approval of this resolution, a total of **thirty-nine (39) parcels** will benefit from the improvement and will be assessed equally for the improvement.

5. Method of apportioning the benefits thereto as provided in SDCL 31-13-46:

There are **thirty-nine** (39) parcels included in the road improvement resolution as outlined in Subsection 4. Each parcel is deemed to benefit equally from this improvement and thus total improvement costs will be shared equally across these thirty-nine (39) parcels.

The total project cost of \$133,575 will be amortized over five (5) assessment years, equaling a total yearly assessment of \$26,715 for the improvement project.

Each of the identified parcels will be equally assessed a total of \$3,425 to be amortized over five (5) assessment years, giving a yearly assessment of \$685 per parcel beginning with taxes payable in 2023.

6. Addition of residential or commercial structures in the improvement zone:

If at any time additional residential or commercial structures are constructed on the zoned within the established improvement zone of this resolution or within the parcels included on a voluntary basis, the newly constructed residential or commercial structure(s) will be included in this assessment and the yearly per parcel assessment will be recalculated for the remaining years of the improvement zone to accommodate the addition.

7. Continuing maintenance costs associated with this improvement:

Future chip sealing, surface painting and other necessary costs to maintain the hard surface will be assessed to the improvement zone as outlined in Subsections 5 and 6. The Board of County Commissioners recognizes there is a base cost to maintain a gravel surface, which will be accounted for when calculating the assessment. The assessment may not exceed the assessment allowed for in SDCL 31-13-51, Annual front foot assessment for maintenance and repairs.

Snow removal and culvert replacements are not included in this assessment and remain the responsibility of the County.

8. Sales of properties:

If property subject to this assessment is sold, the assessment transfers with the property.

9. Dissolution of agreement:

The Board of County Commissioners may vote to revoke this agreement at any time and assume all responsibility for maintenance of the road identified in Subsection 1.

Owners of the parcels included in this assessment may exit this resolution if 90% or more are in favor of dissolving the agreement and the initial project costs have been satisfied through the assessment. At that time, the Board of County Commissioners assume all responsibility for maintenance of the road identified in Subsection I; cost and method of maintenance will be reassessed at the time of dissolution.

The regular meeting of the Yankton County Commission was called to order by Chairman John Marquardt at 6:00 p.m. on Tuesday, April 15, 2025.

Roll call was taken with the following Commissioners present: Wanda Howey-Fox, Ryan Heine, Dan Klimisch, Don Kettering and John Marquardt.

There were no conflicts of interest reported by Commissioners.

Action 25115C: A motion was made by Fox and seconded by Klimisch to approve the meeting agenda. All present voted aye; motion carried, 5-0.

There was one public comment from Bob Gleich. Chairman Marquardt closed public comment.

Action 25116C: A motion was made by Heine and seconded by Fox to approve the Burn Ban Resolution presented by Paul Scherschligt. All present voted aye; motion carried, 5-0.

YANKTON COUNTY RESOLUTION TO PROVIDE FOR EMERGENCY REGULATION OF OPEN BURNING AND DANGEROUS FIRE HAZARDS IN YANKTON COUNTY

WHEREAS, the Commissioners of Yankton County are charged with the protecting the health and safety of the citizens of Yankton County, including all property situated therein; and

WHEREAS, South Dakota Codified Law (SDCL) 7-8-20(18) allows the Yankton County Commission, to prohibit or restrict open burning within Yankton County, after consultation with local fire officials and law enforcement officials, in order to protect the public health and safety; and

WHEREAS, conditions of wildfire and dangerous fire hazards affecting public health and safety have existed in Yankton County; and

WHEREAS, the Yankton County Emergency Management Office is able to respond and monitor conditions of wildfire and dangerous fire hazards in a significantly more expedient process than the Yankton County Commissioners are able to accomplish; and,

WHEREAS, the Yankton County Commissioners hereby deem it necessary, for immediate preservation of public health and safety of Yankton County, to adopt this resolution and allow the Yankton County Emergency Management office to enforce or restrict open burning and monitor conditions of wildfire and dangerous fire hazards within Yankton County; and

WHEREAS, the Yankton County Emergency Management Office shall consult with local fire

WHEREAS, the Yankton County Emergency Management Office shall consult with local fire officials and law enforcement officials concerning the treat of wildfire from open burning under certain climatic conditions that become dangerous to life and property and upon

recommendation of said consultation the Yankton County Emergency manager shall be authorized to prohibit or restrict open burning; and,

WHEREAS, it is the intent of the Yankton County commissioners, that the provisions of this resolution shall take effect immediately upon the passage by the board: and

NOW, THEREFORE, BE IT ORDAINED BY THE YANKTON COUNTY BOARD OF COMMISSIONERS AS FOLLOWS:

SECTION I. **DEFINITIONS:**

- A. Open Fire: Means any outdoor fire, including a campfire, that is not contained within a fully enclosed fire box or structure from which the products of combustion are emitted directly to the open atmosphere without passing through a stack, duct or chimney with spark arresters. Open Fire does not include fires contained within liquidfired or gas-fueled stoves, fireplaces within all buildings, charcoal grill fires at privates residents, and permanent fire pits or fire grates located on supervised developed picnic grounds and Charcoal Grills, Liquid Fuel Grills, Outdoor Fireplaces, and Campgrounds as defined herein.
- Charcoal Grill: Means a metal or Stone device not resting on the ground with a
 metal grate designed to cook food using charcoal briquettes, char wood, hard wood,
 or similar fuel.
- 2. **Liquid Fuel Grill**: Means a metal or stone device designed to cook food using liquefied of gaseous combustible fuel
- 3. **Outdoor Fireplaces**: Means a manufactured appliance constructed of non-combustible materials, with a maximum fuel area of three (3) feet, including a screen, (screen opening shall be no larger than 1/4" square), chimney or other device placed above the fuel area, fueled by cut or split wood, located not closer than 15 feet to any combustible surface and continually attended.
- 4. **Campground**: Means any permitted commercial campground operated by private individuals or corporations, State of South Dakota, or the United States National Park Service unless otherwise specifically banned by resolution of the Yankton County Board of Commissioners.
- B. **Burn Barrel**: Means a metal container used to hold combustible or flammable waste materials so that they can be ignited for the purpose of disposal. Burn Barrels must have a metal grate; metal grate opening shall be no larger than 1/4" square covering at any time when being used. Burn Barrels must be located in a safety zone away from any or all combustible materials 15 feet radius of the Burn Barrel.

SECTION II: REGULATIONS:

NOW, THEREFORE, BE IT RESOLVED, that no person shall set any Open Fire or ignite a fire in a Burn Barrel in Yankton County, outside the boundaries of any Municipality, When the National Weather Service has declared the Grassland Fire Index to be in the Very High or Extreme Category. If the U.S. Drought Monitor should reach a D3 category or higher anywhere in the county, or when the Yankton County Emergency Management Office, through the Yankton County Emergency Manager after consultation with local fire and law enforcement officials initiate a "No Open Burning Ban" by providing notice in a legal newspaper that no person shall set any Open Fire or igniting a fire in a Burn Barrel in Yankton County, outside the boundaries of any municipality; and,

BE IT FURTHER RESOLVED that the No Open Burning Ban shall remain in effect until the Yankton County Emergency Management Office provides notice in a legal newspaper that the No Open Burning Ban has been removed; and

BE IT FURTHER RESOLVED that a fine not to exceed five hundred dollars (\$500) for each violation, or by imprisonment for a period not to exceed thirty days for each violation, or by both the fine and imprisonment, if found in violation of this Resolution, as per South Dakota Codified Law 7-18A-2, and that the costs for suppressing any fire, including response fees, mutual aid assistance from other agencies or fire departments, reimbursement to governments for suppression efforts and compensation to the firefighters for time lost from their employment, be born directly by the individual or individuals responsible for setting the fire.
