On May 24th, Yankton County EMS received four (4) new LifePak15 monitors through the South Dakota LifePak Initiative. These four monitors and accessories were provided at no charge with an estimated value of \$132,000.00. The initiative also includes eight years of wireless data to transmit EKG's as well as eight years of preventive maintenance, which will also save Yankton County thousands of dollars.

There are a few first responder agencies in South Dakota who did not receive new LifePaks, and they would like to purchase our old LifePaks for \$12,000.00 each. We need to have our old LifePaks declared as surplus property so they can be sold. If we hold onto these old LifePaks, they will quickly decline in value and won't be worth as much as they are now.

Notice is hereby given that FIRM bids will be received by Harding County, SD at the office of the County Auditor, PO Box 26, Buffalo, SD 57720 up to 9:30 AM, December 6, 2022 for furnishing of miscellaneous road machinery for construction, repair and maintenance of roads and bridges on the Harding County Highway System.

Bids shall be submitted on an hourly basis for the services of machinery from the contractors and other sources. Bidder shall furnish operator, repairs, fuel, oil, Worker's Compensation or Affidavit of Exempt Status, and other insurance, applicable taxes and all other incidentals. This method is considered full operation of the machinery. Bidders shall designate the name, type, horsepower, year and model of the machinery. Any and all Sub-contractors will be required to file the same documents and information as the primary bidder.

The principle purpose of the contract of services of machinery, if required, is to cooperate with Harding County owned equipment in the construction, repair and maintenance of roads and bridges.

BASIS OF PAYMENT: Must be submitted on an hourly basis for the services of machinery. Progress payments to the Contractor can be made on the basis of applications for payment submitted to the County Highway Superintendent by the contractor. Payments may be made during the progress of work based upon the work completed during the preceding month, but, in no case shall payment exceed 90% of the value of the labor or machinery incorporated in the work until each project is completed and approved by the Highway Superintendent. Statements must be submitted on the 25th day of the month in which services are provided.

The contract for services will be effective from January 1, 2023 through December 31, 2023.

The Board of County Commissioners reserves the right to accept or reject any or all BIDS. To waive any informality in the BID received and to accept the BID that is to the advantage of, and in the best interest of, Harding County,

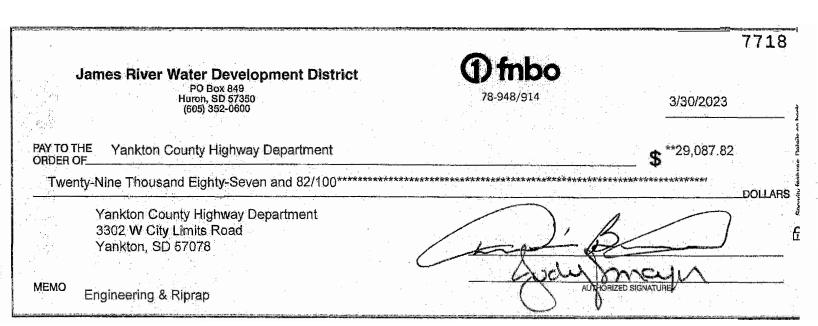
