university."

This year, MMU's student body hails from 26 U.S. states and 18 countries, with many of the international students drawn to MMU's athletics

program, he said.
"But this year, we increased out this year, we increased our non-athlete number of incoming students, and we largely did that through nursing," Franz said. "We had quite a few more students that came to Mount Marty just for nursing, which was exciting to see. Hopefully, this will be something that we can sustain for the next several years as we continue towards our goal of being a preeminent Catholic University focused on rural health and well being."

## YANKTON COUNTY COMMISSION MEETING

October 21, 2025

The regular meeting of the Yankton County Commission was called to order by Chairman John Marquardt at 6 p.m. on Tuesday, October 21, 2025.

Roll call was taken with the following Commissioners present: Dan Klimisch, Don Kettering, Wanda Howey-Fox, Ryan Heine and John Marquardt.

Dan Johnson, representing Risty Benefits, appeared before the board to explain the health insurance options for 2026. Mr. Johnson said premiums will be increasing by 7.25% which is less than previous years. In 2024, Avera officials said they would cap any 2026 increase in health insurance coverage at no more than 8 percent. No action needed.

Interim Director Troy Cowman presented the 2025 third quarter report for the Emergency Medical Services Department. Cowman also mentioned the new rates will take affect November 1, 2025 and said Stryker has checked the department's AED and life packs. The County saved \$6,900 because of the preventative maintenance program.
