CONTRACT SERVICES SPECIFICATIONS

1. Scope of Work
 - a. Successful bidders shall provide construction related services to include noted equipment, operators, repairs, fuel, oil, and incidentals to accomplish projects identified by the County.
2. Insurance Requirements
 - a. Successful Bidder shall provide Certificates of Insurance showing coverage and effective dates of:
 - i. Workman's compensation;
 - ii. General liability; and
 - iii. Vehicle liability.
 - b. The County shall be named as an additional insured on all applicable policies.
3. Construction Requirements
 - a. It shall be the responsibility of the contractor to furnish all labor and equipment to complete the projects as assigned.
 - b. Contractor shall begin mobilization upon a 48-hour notice. If contractor is unable to begin mobilization within these 48 hours, the County may use the next lowest responsible bidder.
 - c. The County will require work to be in compliance with identified specifications and County work orders. Contractors unable to comply with these requirements shall be removed from the operation upon request of the highway superintendent.
 - d. Hours Worked
 - i. Equipment, labor shall be at the work site ready to work no later than 7:15 AM, unless otherwise specified;
 - ii. From approximately mid-April to mid-October, work hours include 10-hour days Monday-Thursday with occasional Fridays. County assistance will be available no later than 4:30 PM; and
 - iii. From mid-October to the mid-April, work hours include five 8-hour days Monday through Friday. County assistance will be available no later than 2:30 PM.
2. Method of measurement
 - a. Contractor to be compensated upon a per hour basis; and
 - b. Hours may be rounded to the nearest one quarter (.25) hour.
 - c. All operators shall provide a reading of the equipment hour meter for each day. These logs shall accompany all requests for payment. Log will show:
 - i. Date;
 - ii. Project number;

- iii. Equipment hours;
 - iv. Employees on site; and
 - v. Operators name.
3. Basis of payment
- a. The agreed upon hours will be paid per the Bid price.
 - b. Requests for payment shall be submitted no later than the 20th of each month.
4. Altering of contract
- a. The cost per hour, year/make, model, type of equipment, capacity/size, and mobilization fee (if applicable) should be the **ONLY** thing written upon the **Bid Form**, no other annotations, calculations or writings allowed. Primary services required are identified in Item #1 Scope of Work; and
 - b. The Yankton County Board of Commissioners, Yankton, South Dakota, will reject any or all bids that are altered either by adding, deleting or changing any of the original wording of the specifications or Bid Form.

Said bidder shall provide Certificates of Insurance showing coverage and effective dates covering workman's compensation, general and vehicle liability. In addition, the County shall be named as an additional insured on all policies.

Therefore, it is hereby agreed by and between the parties hereto, that in consideration of the service to be furnished by the said party of the second part as set forth in the said specifications and Bid, the said party of the first part will pay to the said party of the second part, the sum derived from multiplying the bid price by total hours worked for said service by the party of the second part. The said bidder further agrees to furnish said service upon receipt of the order from the Yankton County.
