At that time bids will be considered for the purchase of the following listed materials to be supplied to Yankton County, for the period of one year from the date of bid acceptance.

At this time all bids will be opened, read aloud and considered for the purchase of the following materials to be supplied to Yankton County, for the period of one year from the date of acceptance of the bid.

*Diesel fuel shall have a maximum sulfur content 0.5% by weight and maximum carbon residue 0.1% by weight. In addition, a low sulfur diesel fuel additive will be added to the low sulfur diesel fuel at the terminal. This is to be added at the proper rate per gallon of diesel fuel. This additive will be included in the bid price per gallon of fuel.*
