



# South Dakota Woman Sentenced In 1981 Death Of Infant Son

SIOUX FALLS — A South Dakota judge on Thursday sen-tenced a woman to 10 years in the state prison system for her infant son's 1981 death that

went unsolved for decades, Judge Bradley Zell called the sentencing of 60-year-old Theresa Bentaas a difficult decision that he belabored for weeks, in part because it was not clear whether her son died from complications during birth or abandonmen in the South Dakota cold, Zell suspended nine years of the sentence, meaning Bentaas will likely spend two months in state prison and serve the rest of her time under community supervision. "This is a terribly sad and

difficult human event which now needs to be brought to conclusion," Zell said, acknowledging that the sentence was likely a bliter pill for both Bentaas' family that had begged for her to go free and community members who had pressed for a strict punish-

Bentaas had entered an "Alford plea" to a first-degree manslaughter charge, mean-ing that she maintained her innocence but agreed to be sentenced as convicted guilty. Prosecutors dropped first- and second-degree murder charges in the plea deal.

Lawyers defending her maintained that Bentaas had not killed her son, but rather he dled soon after a birth that was not expected, even by his

A psychologist who interviewed Bentaas as part of a forensic psychiatric evaluation diagnosed her with "complete pregnancy denial syndrome," saying she did not recognize her pregnancy until she woke up in the middle of the night in the palns of childbirth.

The psychologist, Dr. Cara Angelotta of Northwestern University, told the court on a video call that Bentaas described her infant son as "illetess" and

her infant son as "lifefess" and "ghost-like" immediately after his birth, but did not remem-ber other details of that night She said the shock of the birth could have severely impaired

Bentaas' memory,
The infant's death was uncovered by the curlosity of two
men, witnesses said Thursday. First, Lee Litz told the court he was test driving a jeep with several friends on Feb. 28, 1981 hen he spotted blankets in a

when he spotted biankets in a ditch.
"My curlosity got the best of me and I went over to see what it was." he told the court Thursday. "That's when I found Andrew laying there with his back towards me,"
An autopsy determined that the infant likely dled from fallure to assist in maintaining an airway during his birth and exposure, the Sloux Falls argus Leader reported. Recently, a doctor who consulted with

Leader reported. Recently, a doctor who consulted with Bentaas' defense found that the infant did not die from hy-pothermia. Police were unable portermia. Ponce were unable to find the infant's parents and the case quickly went cold. The baby was burted with a headstone that named him Andrew John Doe.

But nearly three decades

later, the curtosity of a Sloux Falls detective, Michael Web-ber, revived the case. He was moving boxes of case files when he spotted "an old, weathered box" scrawled with the word "murder." It contained cold cases, including the infant's file.

The case intrigued Webber nd he started working on it in

and he started working on it in his spare time. Webber said he did not ini-tially have much to go on — an "extremely smail" case file list-ing physical evidence that had been destroyed. But in 2009, the intant's body was exhumed for DNA suidance.

Initial searches for a family tree came back vold. However, in 2019—once DNA technology progressed and sampling had become more prevalent—a match was revealed. Webber sald after police suspected Bentaas as the mother and Dirk Bentaas as the father, they found DNA samples in their

found DNA samples in their trash that confirmed them as the parents.

Bentaas was arrested in 2019. After several delays in her trial, she entered the "Alford plea" in October.

During Thursday's hearing, Bentaas' hamily begged the judge for a lenient sentence, saying she was a caring mother and grandmother who had carried the secret of her first child's death for years.

Bentaas' daughter, Melissa Phellmeler, told the court, "Andrew and my mother are victims of their situation, victims of the culture and the stigma of

of the culture and the stigma of a young, unwed pregnant girl in 1981."

#### Iowa, Nebraska Get Millions In EPA Funds

DES MOINES, lowa (AP) --- Iowa is getting \$110.7 million and Nebraska \$63.4 million from the federal government to upgrade

Nebraska \$63.4 million from the federal government to upgrade water systems and improve water quality, the Environmental Protection Agency announced Thursday.

EPA Administrator Michael S, Regan informed states of \$7.4 billion in new funding, saying the allocation for next year is the first of five years of payments totaling nearly \$44 billion. The EPA funding comes through a \$1 trillion infrastructure bill approved by Congress and signed into law last month by President Joe Biden.

Some of the funding would be focused on removing lead and PFAS compounds, widely known as "forever chemicals" linked to health problems including cancer, liver damage and decreased fertility.

## US Is Still Battling COVID's Delta Variant

For now, the extra-contagious delta variant accounts for practically all cases in the U.S. and continues to inflict misery at a time when many hospitals are struggling with nurse shortages and a backlog of patients undergoing procedures that had been put off early in the pandemic.

"For me, it's really just, I can't imagine," said Dr. Natasha Bhuyan, a family phystican in Phoentx, which has also been hit hard.
