INTRODUCTION

- a) The County of Yankton; Yankton County EMS is bidding to remount their MedTec Ambulance module onto a new 2022 Chevrolet K3500 4x4 Diesel Chassis.
- b) The specifications found herein for the project are the minimum for all materials, level of quality and workmanship. The specifications should not prevent the bidder from bidding their standard or to propose alternatives for ambulance rechassis and module reconditioning if it can be shown to exceed the minimum standard required by this specification. The bidder is encouraged to propose a like equivalent or better alternative for those items in the specifications, which they cannot comply to. Alternative methods and materials in construction and design detailed by the proposer shall not be cause for automatic rejection. However, in instances where exceptions and clarifications to the specifications by the bidder are necessary, detailed information and descriptions (including photos as applicable) are required for consideration.
- c) The County of Yankton reserves the rights to reject any and all proposals received and accept any bid that, in its judgment, best serves the interest of the Department and public.

GENERAL INFORMATION

- a) The Bids, Plainly marked "Sealed Ambulance Bid" will be received by Yankton County Board of Commissioners at the office of the Yankton County Auditor at 321 W. 3rd Street, Yankton, South Dakota 57078 until <u>TIME on DATE, 2021</u>. No late bids will be accepted.
- b) All Bids must contain a filled out **Bid Form** and also a properly executed **Tax Identification/Certification**.
- c) Bids which are not received by the deadline, incomplete, not properly endorsed or signed, or otherwise contrary to instructions will be rejected as non-responsive by the Auditor's Office. Conditional Bids will not be accepted.
- d) As the County of Yankton is exempt from the payment of Federal Excise Taxes and South Dakota Sales Tax, prices quoted herein are not to include these taxes.
- e) The Yankton County Commission reserves the right to reject any and all bids, in total or in part.
- f) The Vendor will be bound by all applicable statutory provisions of law of the Federal Government and the Codified Laws of South Dakota.

- g) This project will be compliant with all KKK-A-1822 Standards.
- h) Any inferior or damaged product, as determined by the Yankton County Commission, will be replaced at the total expense of the Vendor.
- i) Any restrictions, qualifications, or deviations from specifications must appear either on the Bid Form or on an attachment thereto.
- j) A contract will be signed between the awarded bidder and the Yankton County Commission. BID EVALUATIONS

a) Bidders will be evaluated on qualifications, price, and completeness of bid proposal following specifications, proposed timetables for completion, and references.

b) Minimum bidder qualifications:

REMOUNT REQUIREMENTS

Chassis:

Interior Electrical:

- a) Install a new solid state electrical system in modular body; solid state relay boards, relay controlled, self-resetting circuit breaker protection
- b) Install new front switch panel and new rear switch panel with new LED Carling rocker switches for controls.
- c) Front Switch Panel to have "Module Disconnect" switch battery on to be controlled by ignition through Commander
- d) Replace/Update/Reuse modular electronic door locks with rocker switch in Front Switch Panel.
- e) Module to have timer activated interior lighting for re-stocking and check-out purposes
- f) Re-use existing siren head
- g) Install new back-up camera system integrated to chassis screen
- h) Install 2 36" LED fixtures
- i) Inspect all interior dome lights and lenses for operation and appearance- replace as needed
- j) Install USB charging ports in front console switch panel; 2.1A and 1.0A ports
- k) Install USB charging ports in rear action area (integrated in 110v receptacle; 3.1A ports

HVAC, Ventilation, Oxygen, & Vacuum

- a) New Heat & A/C unit with hoses, fittings, and brushless blower motor
- b) Install a new digital thermostat with automatic climate control
- c) Leak test oxygen system replace as needed
- d) Test suction pump for proper operation and inspect vacuum lines replace as needed
- e) Inspect patient compartment exhaust fan for proper operation and replace as needed

Outside Finish:

- a) Install new exterior aluminum diamond plate rock guards, rub rails, etc.
- b) Install new ADP rear kick plate with new license plate housing
- c) Install new rear bumper with ADP end caps
- d) Polish and re-use fenderettes; replace as needed
- e) Adjust and lubricate all compartment and entry door latches and hardware replace as necessary
- f) Install non-skid on all grip surfaces of exterior door latches
- g) Inspect and replace door check hardware as required
- h) Install new door seals on compartment and entry doors as needed
- i) Install new aluminum entry door panel latch inserts
- j) Install metal rear corner guards on patient compartment, minimum of 24" from bottom of ambulance box, maximum of 30".

Inside Finish:

- a) Thoroughly clean and inspect existing modular floor
- b) Inspect cot mount provisions
- c) Inspect the cot safety catch
- d) Check, adjust and replace cabinet door latches and interior cabinet hardware as necessary
- e) Inspect existing squad bench seat belts for wear and operation replace as needed
- f) Inspect all modular upholstery for damage and replace with matched color as needed
- g) Install a new Intellitec time manager digital clock

Miscellaneous:

a) Clean entire truck inside and outside

- b) Performance test entire vehicle and inspect with 100+ point checklist
- c) Chassis trade in allowance (2014 Chevy K3500)
- d) Chassis Manufacturer Rebate

GENERAL REQUIREMENTS

Completeness of Bid Proposal:

WARRANTY (minimum)

Chassis Warranty

Modular Structural Warranty shall be twenty (20) years from date of delivery of ambulance. This shall include material and workmanship.

Ambulance Conversion Warranty shall be ten (10) years from the date of delivery of the ambulance. Ambulance shall be free of substantial defects and shall include material and workmanship.

Ambulance Electrical Wiring System Conversion Warranty shall be ten (10) years from date of delivery of the vehicle.

PPG Ambulance Paint Conversion Warranty shall be five (5) years from the date of delivery. Paint warranty shall cover any painting done by ambulance manufacturer.

One (1) Year General Warranty from Date of Pick Up/Delivery to the original retail purchaser to be free from defects in material and workmanship supplied.
