

YANKTON COUNTY COMMISSION MEETING

November 15, 2022

The regular meeting of the Yankton County Commission was called to order by Chairman Joe Healy at 6:00 p.m. on Tuesday, November 15, 2022.

Roll call was taken with the following Commissioners present: Don Kettering, Wanda Howey-Fox, Dan Klimisch, Cheri Loest and Joe Healy.

There were no conflicts of interest reported by Commissioners.

Action 22441C: A motion was made by Fox and seconded by Loest to approve agenda with addition of executive session for personnel issues SDCL 1-25-2(1). Fox, Loest, Kettering and Healy voted aye; Klimisch voting nay; motion carried, 4-1.

There was no public comment. Chairman Healy closed public comment.

Yankton County Ambulance Director Steve Hawkins appeared before the board to present new and updated ambulance job descriptions. No action was taken.

Dana Schmidt from Yankton Community Library appeared to update the board on statistics from the 2021 annual YCL report and request approval of agreement for the provision of library services to county residents outside of the City of Yankton.

Action 22442C: A motion was made by Klimisch and seconded by Fox to approve the Agreement for Provision of Library Services. All present voted aye; motion carried, 5-0.

Highway Superintendent Mike Sedlacek appeared for approval of Resolution 22-06 to establish criteria to award Rural Action Infrastructure Funding.

Action 22443Hwy: A motion was made by Klimisch and seconded by Loest to approve the following resolution. All present voted aye; motion carried, 5-0.

RESOLUTION Yankton County 22-06

TO ESTABLISH CRITERIA TO AWARD RURAL ACTION INFRASTRUCTURE FUNDING

WHEREAS, in 2021, SDCL § 31-34 (Rural Access Infrastructure) was enacted to provide funding for counties and townships to inventory their small structures, identify needs and plan improvements and to fund construction, rehabilitation, and maintenance of small structures on township and county secondary highways;

WHEREAS, in 2021, Yankton County received its share of funds from the State of South Dakota and, as required, inventoried its small structures, identified needs, and planned improvements of certain small structures;

WHEREAS, in 2022, Yankton County received its share of the \$11,333,333.33 million additional funds to award rural access infrastructure grants to local public agencies, including townships;

WHEREAS, as statutorily required, Yankton County created a Rural Access Infrastructure Fund ("RAIF") in which to deposit moneys it received under SDCL § 31-34;

WHEREAS, SDCL § 31-34-4 creates a process for townships to apply for RAIF grants;

WHEREAS, SDCL § 31-34-5 requires county commissions to consider certain criteria in awarding RAIF funds; now it is hereby

RESOLVED that Yankton County hereby establishes the criteria to be considered in awarding Rural Access Infrastructure grants as follows:

Yankton County RAIF Funding Award Criteria

Pursuant to SDCL § 31-34-5, the Yankton County Board of County Commissioners shall, at a minimum, consider the following criteria in awarding rural access infrastructure grants:

(1) Traffic use of the highway;

- Use SDDOT Bridge Improvement Grant ("BIG") formula as follows
 - User Impact (20 points maximum) - User Impact will be a variable that measures impact on users of the culvert and will be calculated by multiplying the Average Daily Traffic ("ADT") for the bridge by the Detour Length. The points will be assigned based on the following formulas with the maximum value for user impact capped at 20 points: $\text{User Impact} = \text{ADT} \times \text{Detour Length (miles)} / 100$

(2) Public Safety;

- Structure to be in poor condition to qualify, points given based on condition:

• Structure Condition	Good	0
	Fair	0
	Poor	5
	Critical	10
- Posted Structure

No Posting	0
Posting	10

(3) Residential, commercial, recreational, and other uses of the highway, points given based on use:

- Residential 1
- Commercial 2
- Recreational 2

(4) Cost of the Project;

- Follow BIG formula
 - For any Local Public Agency ("LPA") cost share beyond the required 20%, additional points will be awarded as shown in the Table as follows:

- (7) If the highway does not terminate into a field entrance, driveway, single residence, farm, or ranch;
 - Pass/Fail
- (8) The application, or group of applications, that best serves the citizens of this state; and
 - Pass/Fail
- (9) Any other matters deemed applicable by the Board of County Commissioners, including but not limited to application failure in previous year at same location, 5 points granted.

ESTABLISHING REDUCED SPEED LIMIT FOR HIGHWAY

WHEREAS, pursuant to SDCL 32-25-9.1, the Yankton County Board of Commissioners may determine and establish speed zones upon all or any part of the highways under its jurisdiction having charge of the maintenance of its roads; and,

WHEREAS, that portion of the Yankton County road 434th Avenue from SD HWY 50 to Kaiser Road in the approximate distance of 7,900 feet and that portion of the Yankton County road Kaiser Road from SD HWY 153 (435th Ave) to 434th Avenue in the approximate distance to 5,500 feet has seen a significant increase in residential dwellings and residential traffic; and,

WHEREAS, the speed limit on the Residential Road is currently 40 mph; and,

WHEREAS, the Yankton County Highway Superintendent recommends that the herein described roadways' speed limit be reduced to 30 mph to ensure the safety of travelers on

said roadways due to the significant number of residential traffic and residential dwellings located thereon and nearby; and,

WHEREAS, pursuant to SDCL 7-18A-8, the adoption of a resolution may take effect immediately for the preservation of the public peace, health, or safety.

NOW THEREFORE BE IT RESOLVED by the Yankton County Board of Commissioners, in accordance with SDCL 32-25-9.1, declares that the Yankton County Highway Department is hereby authorized to reduce the speed limit on 434th avenue to 30 miles per hour from SD HWY 50 to Kaiser Road in the approximate distance of 7,900 feet and the Yankton County Highway Department is authorized to reduce the speed limit on Kaiser Road to 30 miles per hour from SD HWY 153 (435th Ave) to 434th Avenue in the approximate distance to 5,500 feet; and,

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately.
