## YANKTON COUNTY COMMISSION MEETING August 15, 2017

**Action 17262C**: A motion was made by Epp and seconded by Woods to approve the consent agenda. All present voted aye; motion carried.

The Yankton County Welfare Report for July 2017 included 13 contacts, 18 notices of hospitalization, and 4 medical bills for the County Jail.

**ROD**: The Register of Deeds report from July 2017 showed collection of \$13,010.00 in regular fees; \$9,883.50 in transfer fees; \$2,001.00 in copies revenue.

**Veterans Office**: VSO Michael McDonald's July 2017 report showed 144 contacts on behalf of veterans last month. McDonald also coordinated transportation of 24 veterans (seven trips) to appointments at the VA Hospital in Sioux Falls.

**EMS**: Emergency Medical Services monthly report for July 2017 listed 173 total calls. Year to date, Yankton County EMS has collected \$411,100 and spent \$545,188.

**Auditor/Treasurer:** The Auditor's Monthly Settlement with the Treasurer as of July 31, 2017 showed Total Cash of \$8,607,119.05. The General Fund was \$5,181,066.77; Special Funds were \$2,165,409.67; and Trust and Agency Funds were \$1,260,642.61 adding to a Grand Total of General Ledger Cash and Investments of \$8,607,119.05. A detailed report is on file with the County Auditor.

MI Income: The MI Illness income for July 2017 was \$5,782.40.

**Sheriff**: Sheriff's office collected \$9,716.41 in fees last month. Jail income was \$165,328.28 in June. There were 83 county inmates, 109 city inmates, 27 state inmates and 47 federal inmates. Income from the 24-7 program was \$6,337.00 in July.

**Plat**: Whereas it appears, Donald Bohnet, owner of record, has caused a replat to be made of the following real property: Ranch 2A, Ranch Estates in the W1/2 S4-T93N-R55W, County of Yankton, S.D., and has submitted such plat to the Yankton County Planning Commission and the Yankton County Commission for approval. **Health Nurse**: Julie DeYonge, RN, provided the 2017 second quarter report from the S.D. Department of Health and Yankton County WIC Office.

**Action 17263C**: A motion was made by Bodenstedt and seconded by Epp to accept the S.D. Department of Health and Yankton County WIC Office Report for April, May and June 2017. All present voted aye; motion carried.

**Corridors**: Highway Superintendent Brian Gustad and Greg Vavra, program manager with the South Dakota Local Transportation Assistance Program (SDLTP), discussed setting certain roads as priority corridors in the five-year plan. Gustad stated he would like this done before the five-year plan is completed. Vavra said there could be a public meeting to have citizens voice their opinions. The five-year-plan must be completed and sent to the Department of Transportation by October 13.

**Abatement**: Abatement request was rescheduled to the next commission meeting.

**Welfare Bill**: Roger Hakl appeared before the board to discuss cancelling the balance of his county medical lien. The balance of the claim is \$272.52.

**Action 17264C**: A motion was made by Bodenstedt and seconded by Epp to have Mr. Hakl continue paying what he can and when it is no longer feasible, the board will revisit the request. Woods, Epp, Bodenstedt and Kettering voting Aye; Swensen Voting Nay; motion carried 4-1.

**Documents and Permits**: Dan Grant read a letter along with the codified law definition of public records. Grant said he wanted to enlighten the board and the public of these codified laws regarding what is public documentation and those available to the public.

**Turkey Valley Ditch**: Craig Hansen, Treasurer of the Turkey Valley Ditch Board, appeared to present a report on the cleaning of the ditch and explore the possibility of converting it to a watershed. Ron Gillen from Brosz Engineering also commented on the watershed option.

**Utica Bridge**: The board discussed the request to help fund replacement of a small bridge in Utica Township. Bob Cap, representative from Utica Township, was on hand for any additional questions. Commissioner Epp suggested helping each township with one project per year. Majority of the commissioners could not support the request. Commissioner Swensen supported funding part of the project.

**Action 17265C**: A motion was made by Swensen to fund part of the project. Motion died for lack of second.

**Archery**: The board discussed the Archery Association's request to help fund the 2018 Archery Youth World Championship. The commissioners said they had received numerous phone calls from the public to not help fund the Archery Association event.

**Action 17266C**: A motion was made by Bodenstedt and seconded by Epp to not fund the 2018 Archery Youth World Championship. All present voted aye; motion carried.

**Roads and Bridges**: Commissioner Swensen asked the meeting audience if they had any questions on county roads. Three came forward to speak on different issues.

Commissioner Epp reminded the public of the organized/unorganized meeting that will be held Wednesday August 23, at 7:00 at the Government Center in the Commission chambers.

The September 19 commission meeting will be rescheduled to September 20, 2017 because of the State County Convention.

**Action 17267C**: A motion was made by Swensen and seconded by Epp to adjourn. All present voted aye; motion carried.

The next regular meeting will be Wednesday, September 5, 2017.
