YANKTON COUNTY COMMISSION MEETING

February 15, 2022

The regular meeting of the Yankton County Commission was called to order by Chairman Joe Healy at 6:00 p.m. on Tuesday, February 15, 2022.

Roll call was taken with the following Commissioners present: Wanda Howey-Fox, Cheri Loest, Dan Klimisch, Don Kettering and Joseph Healy.

There were no conflicts of interest reported by Commissioners.

Action 2269C: A motion was made by Loest and seconded by Fox to approve the meeting agenda with the following addition: 7A Emergency Management transfer accumulated dollars. All present voted aye; motion carried, 5-0.

There were no public comments. Chairman Healy closed public comment.

DOE: Yankton County Director of Equalization Jessica Atkinson appeared before the board to present her annual report and also discussed dates for the local and consolidated boards of equalization, for the assessment appeals process. The board scheduled April 29, 2022 at 10:00 a.m. for county appeals.

Highway: Highway Superintendent Mike Sedlacek appeared for approval on six items: Annual 2022 Highway bids, transfer funds, equipment request, 2022 Bridge Inspection Resolution, SDDOT Transportation Study and Grant Application.
