## Critical Incident Stress Debriefing/First Responder Mental Health capabilities

Terry stressed how important it is to keep in touch and ask members of their department how they are doing and check in with them frequently especially after dealing with "tough calls". April Denholm provided information that cover State Resources that are available to 1<sup>st</sup> responders (see attached).
